

REMSA Save the Heart You Love contest | January 29, 2019

NO PURCHASE REQUIRED TO ENTER OR WIN.

- 1. Eligibility: Open to legal residents of the United States (excluding RESIDENTS of OVERSEAS MILITARY INSTALLATIONS, PUERTO RICO and OTHER U.S. TERRITORIES), age 21 or older at the time of entry. Contest is subject to all applicable federal, state and local laws and regulations and is void where prohibited by law.
- **2. Agreement to Official Rules:** By participating in the Contest, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor(s), which are final and binding in all matters related to the Promotion.
